Discussion:

LMT asked for clarification on what the entry guidelines were for Pentathlon. Is it really the top two swimmers in each age group and gender? Richboro said there is a little more leeway than in years earlier. They need to make sure that whoever is sent can compete in all 5 events. For bigger teams, once you have determined who the top two are for each age and gender, if there are others, reach out to Richboro and they well see what they can do.

LMT asked if they have one pool of applicants, or two. Meaning if there are 8 slots, do they send the 8 fastest swimmers for LMT A and LMT B? They were asked if LMT A and LMT B are separate teams. Yes, then you send 4 from one team and 4 from the other. And then reach out to Richboro to see about sending some of the other qualified swimmers.
